("ZoomInfo"), together are exchangeable for shares of Class A common stock of ZoomInfo on a one-for-one basis at the discretion of the holder, subject to exchange rate adjustments for stock splits, stock dividends, and reclassifications. These exchange rights do not expire. Shares of Class B Common Stock have no economic value and have 10 votes per share.
- Reflects a distribution of OpCo Units to one or more employees of ZoomInfo and its subsidiaries.
